Clerical Support - Vital Statistics

Birth and death records are kept on file dating back to December 1908. Vital Statistics offices in Ohio utilize a uniform security paper for issuance of birth and death certificates. Effective December 2010, the Sidney-Shelby County Health Department gained access to the statewide birth record database maintained by the Ohio Department of Health. With the implementation of statewide access, individuals may obtain certified copies of an Ohio birth record from their local health department regardless of the county where the birth occurred. Participation by local departments is optional and may not be available at every health department. Certified birth certificates are issued for many legal purposes from obtaining social security numbers to driver's licenses. Death certificates are needed for insurance claims and to change social security benefits after death. Birth and death records can assist in genealogy research. Statistical examination for epidemiological purposes can also be done, assisting in community assessment activities.

Environmental Health

The Environmental Health division had another busy year protecting public health in Shelby County with the various environmental programs. The potential of food-borne illness was reduced by inspections made of all licensable facilities that sell food. Water supplies were protected by inspections made on household sewage and private water systems. Some of the other programs such as campground, manufactured home park, public swimming pools/spas, school, and plumbing programs also helped to ensure the well being of county residents. Many nuisance and solid waste problems were also abated. Much time was also dedicated to disaster planning and disease control activities. Public places and places of employment were investigated to ensure compliance with the Smoke Free Workplace Law. Anyone having questions for the environmental division is encouraged to call.

The Ohio swimming pool rules are currently under rule revision. All licensed pool/spa operators will be notified of the changes that affect them.

Waste Disposal

The transportation, storage and disposal of all garbage, refuse, septage, and infectious waste are monitored to prevent nuisance conditions. Special solid waste clean-up projects are conducted to assist townships and villages. Almost 40 tons of solid waste was collected and properly disposed of as

part of four clean-up sites organized by the Health Department in collaboration with township officials from Dinsmore, Orange, Perry and Turtle Creek townships. Scrap tire storage is reduced and monitored throughout the county. A scrap tire disposal day was also held in partnership with the Shelby County Recycling Center. Shelby county residents were allowed to bring up to 9 tires per load to the pick-up location at no charge.

Smoke Free Workplace

Chapter 3794 of the Ohio Revised Code (ORC) prohibits all forms of tobacco smoke in all public places and places of employment and in areas immediately adjacent to the ingress or egress of the public place or place of employment. Smoking complaints are investigated to ensure compliance with the Smoke Free Workplace Law.

Sewage Treatment Systems

All land surveys of lots less than five acres in size and surveys that reduce acreage from a lot with an existing sewage system are reviewed to ensure they meet minimum standards of residential lots. New and existing household sewage disposal systems are inspected to ensure the systems conform to existing installation and operational standards. Septage hauler trucks are inspected and septage disposal is monitored to prevent nuisance conditions and disease. A new sewage law for the State of Ohio in September of 2010 became effective. A new set of statewide sewage rules will be adopted by Public Health Council no earlier than January 1, 2012.

Housing/Nuisance Conditions, Rabies Control

Dwellings with suspected problems are inspected for sanitation, fire and safety hazards. Homes must be brought to minimum standards for health and safety reasons. The Health Department is responsive to any nuisance complaint or request to investigate an environmental condition that may threaten public health. This can include insect and/or rodent control. All animal bite incidents are investigated to ensure the control of rabies.

Immunizations

The Sidney-Shelby County Health Department immunization program provides services to physicians, staff and clients to prevent and protect the public against vaccine preventable diseases.



The Immunization Coordinator provided MOBI (Maximizing Office Based Immunization) education to 11 physicians and their office staff. The AFIX Immunization Program (Assessment, Feedback, Incentives and Exchange) Immunization Program was completed for 7 providers including the SSCHD. The percent of 2 year old children, in Shelby County, who have completed the vaccination series on schedule is 73% (an increase of 2.5%). SSCHD immunization rate for 2 year olds is 77%.

International Travel consultation and vaccinations are available by appointment.

Immunization clinics are available every Monday and the 2nd and 4th Tuesday of the month. Clinics are on a walk-in basis. Appointments will be scheduled as needed.

Communicable Disease Control

The Sidney-Shelby County Health Department is responsible for the investigation and follow up of Shelby County's reportable infectious diseases. A team that consists of two Registered Nurses, one Registered Sanitarian, one Clerk and an Epidemiologist is available to complete these tasks.



The SSCHD newsletter "It Takes a Community" was provided biannually in 2010 to Shelby County healthcare providers and their staff. The newsletter provides information on vaccines, vaccine preventable diseases, reportable diseases with reporting resources, public health programs and the program staff. A folder was provided to all Shelby County Healthcare Providers in 2010 with information on disease reporting responsibility. Cooperation in disease reporting is invaluable to public health. The Sidney Shelby County Health Department continues to be available 24/7 for reporting Class A diseases or public health emergencies.

Sidney Shelby County Health Department is in the process of establishing a STD task force to assess the increase in STD rates/cases in our county (63% increase from 2009 in Chlamydia cases).

This program is designed to provide assessment, support and education to the parents of the newborn. The visit is made by the Public Health Nurse trained in newborn issues and topics (SIDS, growth & development, breast-feeding, etc.). The visit is free and voluntary.

School Health

The Schools of Shelby County (City, Parochial, & County) contract with the Sidney-Shelby County Health Department for Public Health Nurses to provide school health nursing services. Services include: communicable disease checks and follow up, vision screening and referral, multi-factored evaluation screenings, involvement on school wellness teams, student and staff health fairs, health education classes (dental care, handwashing, hygiene, puberty, growth and development, abstinence) and in-service trainings for staff.



Daily Clinics are provided at Anna, Ft. Loramie, and Hardin-Houston schools, daily visits to students in the multi-handicap units (g-tube feedings, medications, suctioning, catheterizations) and services to diabetic and asthmatic students.

Mandatory Immunization State reports were completed for 645 kindergarten students, 518 new students, and 646 seventh grade students.

The Sidney Shelby County Health Department, Compassionate Care, the Schools, and the Shelby County Dental Association collaborated to make 2010 Give Kids A Smile Day a success. 48 students were seen (uninsured) with 2 unable to attend. All 46 seen were followed by dentists for 6 months.

Health Promotion

Ohio Baby Buckles Program is administered by the Sidney-Shelby County Health Department which provides a car seat after viewing car seat education. The car seat technicians checked 37 seats with 92% incorrectly installed. Funds received from United Way purchased 54 infant care seats for distribution in 2010. Car seat checks are by appointment.

Education to the public includes Parent/Child Sexuality Education, Daycare Communicable Disease Course, topics of H1N1, washing hands and cover your cough, and Nutrition.

Women, Infants & Children (WIC)

The Sidney-Shelby County Health Department received the WIC (Women, Infants and Children) Grant and moved the program to the Health Department in October 2006. WIC is a supplemental nutrition education program. WIC provides nutritious foods which promote good health for pregnant women, women who just had a baby, breastfeeding moms, infants, and children up to age five.

WIC provides nutrition education and support, breastfeeding and support, referral for health care, immunizations screening and referral, and supplemental foods. Wilson Memorial Hospital also provides nutritional counseling to high risk clients in the WIC Clinic.

In 2010, the Sidney Shelby County Health Department WIC Program adopted the Peer Program. Peer helpers (past WIC moms) provide basic breastfeeding information and support for WIC mothers. With the Peer Program, the WIC program will see dramatic impact in breastfeeding duration and initiation, giving babies a healthy start in life.

Public Health Emergency Preparedness

2010 was the 9th year the Sidney-Shelby County Health Department (SSCHD) received funding through the Ohio Department of Health from the U.S. Department of Health and Human Services for Public Health Emergency Preparedness (PHEP).

In 2010, planning, training and exercises for all hazards continued to be emphasized. Additional funding was provided as an addendum to the PHEP grant for pandemic planning, training and response. This was identified as Public Health Emergency Response (PHER) funding. These funds were essential in our planning and response during the 2010 period of H1N1 pandemic of 2009-2010. With lessons learned during the H1N1 response we have identified areas for improvement. These improvements will be added to our public health emergency response plans.



The Sidney-Shelby County Health Department focused on completing appropriate vaccination against the H1N1 pandemic virus in early 2010. This was accomplished by offering school based flu vaccine clinics and additional vaccine clinics at the SSCHD. In addition to this planning, PHER funding was essential in providing the resources needed to purchase supplies and equipment needs identified during our actual public health emergency response.

The Shelby County Medical Reserve Corps volunteers and additional qualified, "just in time" trained volunteers were invaluable at all clinics! An appreciation banquet was held for these volunteers in April of 2010 to show our appreciation.

Pandemic Preparedness began in 2006 and what we have planned, exercised and trained for over the last five years was invaluable in our response to an actual Pandemic. The Sidney-Shelby County Health Department will continue to remain vigilant through education, planning, training, exercising and responding to future public health threats if they arise.
