#### ENVIRONMENTAL HEALTH REPORT

# <u>Alyshia Meyer (Dumke), 3633 S. Kuther Rd., Sidney – Gubella's Café/Gubella's Spooky Sips – Referral</u> to County Prosecutor

Erica Lentz presented this agenda item.

## Situation:

Ms. Meyer is selling specialty coffee drinks and fried donuts from her home. Facebook posts posted by Ms. Meyer claimed that she is fully licensed, which she is not. Section 3717.41 of the ORC states: "Except as provided in section 3717.42 of the Revised Code, no person or government entity shall operate a food service operation with a license". A letter was emailed and mailed to Ms. Meyer on August 29, 2025 ordering her to cease operation of her food service. Ms. Meyer posted on Facebook on September 15, 2025 that she was taking orders. Ms. Meyer has failed to comply with the order to cease her food service operation.

#### Staff Recommendation:

Refer this matter to the County Prosecutor for legal action.

Mr. Ankney moved, seconded by Mr. Holthaus to refer Ms. Meyer to the County Prosecutor for legal action. Motion approved.

## Skylar Brown, 1574 S. CR 25A, Sidney - Order to Remain Vacant; Order to Vacate

## Situation:

Mr. Brown has a failing aerobic household sewage treatment system and has failed to obtain a perpetual maintenance contract for aerobic HSTS.

Dr. Vasko moved, seconded by Mr. Ankney to approve the Order to Remain Vacant/Order to Vacate. Motion approved.

Erica Lentz shared the Water Pollution Control Loan Fund Flyer that was distributed. The health department received this grant to help Shelby County residents with failing sewage systems. There have been three applications. The grant award is \$150,000.
