Environmental Health Updates

Miami County Health Department sent out letters to homeowners regarding repairs needed to homes. The Sidney-Shelby County Health Department contracts with Miami County Health Department for plumbing services. There is a group of homes near Anna whose sewer vent pipe was not properly vented. The repair will be completed at no cost to the homeowners and reinspected by the Miami County Health Department's Plumbing Division.

A letter was shared with the Board from Grid Growth. Grid Growth sent the letters to homeowners in Shelby County regarding a project to install 765 and 345-kilovolt transmission towers. The letters stated homeowners may be contacted by the company to survey the homeowner's property.

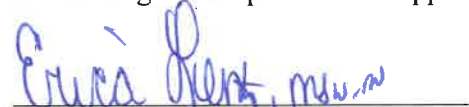
